Mr Hoh's appointment as a Non-Executive Director ("NED") will take effect from 3 August 2020. The Nominating Committee ("NC") had recommended, and the Board had approved, Mr Hoh's appointment having considered that he was previously a NED of the Company and stepped down in December 2019 only in order to meet the requirement for majority independence on the Board of HLGE. With the recent resignation of Mr Tan Eng Kwee as a NED of the Company on 20 July 2020, the Board size had dropped to four Directors, comprising a non-independent Board Chairman and three independent Directors. The NC and the Board are of the view that Mr Hoh's appointment as a NED is appropriate as he is currently a Director and the President of China Yuchai International Limited, a controlling shareholder of the Company.
