As at 4 September 2020, Well Summit Investments Limited ("WS"), a wholly-owned subsidiary of Hong Leong Asia Ltd., had increased its interest in China Yuchai International Limited ("CYI") to 20.29%. CYI is deemed under Section 4 of the Securities and Futures Act, Chapter 289 ("SFA") to have an interest in the 47,107,707 ordinary shares of HLGE held by GSS, an indirect wholly-owned subsidiary of CYI. Accordingly, WS is also deemed under Section 4 of the SFA to have an interest in the 47,107,707 ordinary shares of HLGE held by GSS by virtue of it being entitled to exercise or control the exercise of not less than 20% of the voting shares in CYI.
